

**FOOTHILLS COMMUNITY CHRISTIAN SCHOOL
DRESS CODE GRADES 9-12 (Senior High)**

At FCCS we want to encourage the students in the way of godliness. The dress code for grades 9-12 has been developed with the desire to emphasize modesty, dignity and respect. The way in which students attire themselves can be a vehicle for self-control and purity. We desire that our dress be honorable to the Lord Jesus. Our areas of concern are tops that are too low-cut, too short and too tight and skirts and shorts that are too short. As you shop with your student for dress code clothing we ask you to bear these things in mind.

CHAPEL DAY:

Girls: Skirts, jumpers and dresses of any color, pattern or print at knee length or longer, slits must not be any higher than the knee. When temperature is 32 degrees (actual temperature) or below, girls may wear slacks. No polo shirts, please.

Boys: Must wear slacks (no cargo pants) with collared button up shirt, tucked in with a belt. No polo shirts, please.

ALL OTHER SCHOOL DAYS:

Boys and Girls:

Shirts and tops: Must be modest, not low-cut or sheer. Sleeveless tops are not allowed. Shirts may have a small logo.

Sweaters, sweatshirts, jackets, coats, turtlenecks, mock turtlenecks, vests: All colors, prints, and patterns may be worn.

Slacks, Shorts, Pants and Cargos : Cotton, cords, cargo and pleated pants of any color, print, or pattern are allowed. Dress shorts are allowed, no cut-offs or gym shorts. Length of shorts should clearly extend past the tips of your fingers when arms are resting at your side.

Jean Friday: Blue jeans (pants, shorts, skirts, skorts and capri's) may be worn on Fridays.

Shoes: styles optional, including sandals and flip-flops.

Modesty Issues:

- No see-through or clingy materials are allowed.
- At no time should midriffs or underwear show.
- Clothing should be appropriately sized. No form-fitting, tight, or baggy extremes.
- Neckline – no scoop neck, wide neck or deep V shirts are to be worn at any time.

Limitations:

- No blue jeans or denim skirts (exception is Jean Friday for 9-12).
- No holes in pants or jeans.
- No fraying, fringes at the seams, hems, or end of cuffs. No added rhinestones, beads, etc.
- No writing or graphics on clothing (small trademark or logo allowed & any Foothills school graphics).
- No sweat pants, sports shorts, nylon warm-ups or parachute pants allowed.
- No zip-off pants. Cargo pants should not have excessive pulls, pockets, and zippers.
- No solid black outfits.
- No spandex or fishnet stockings - solid colored, solid leggings may be worn under skirts and jumpers.
- No visible tattoos or piercings (exception: ear piercings that are not excessive allowed for female students.)
- Natural hair colors only.
- No hats or caps worn in the building (includes hoods).

Consequences:

The following consequences will be enforced for violation of the dress code, specifically if attire is in violation of modesty.

- 1st offense:** A warning will be issued and clothes must be changed in order for the student to remain in school for the day. The student will be allowed to call home to have a change of clothes brought to them or they can get clothes from our Y-Buy shop.
- 2nd offense:** Clothes must be changed in order for the student to remain in school for the day. The student will be allowed to call home to have a change of clothes brought to them or they can get clothes from our Y-Buy shop. Additionally, the student loses the privilege of wearing Senior High dress code and will be required to return to wearing the Junior High dress code for one week.
- 3rd offense:** Clothes must be changed in order for the student to remain in school for the day. The student will be allowed to call home to have a change of clothes brought to them or they can get clothes from our Y-Buy shop. Additional consequences for these students will be at the discretion of the Administrator.
